Youth Ministry Summer Trip Teen Agreement

The chaperones for this Trip are assuming responsibility for me. By signing this agreement for the Youth Ministry Summer Trip I agree I will accept the responsibility for my own actions. I agree that :

- *I will respect and follow any reasonable directions given to me by Parish Youth Ministers, Chaperones, and other Adults .
- *I will avoid activities that may cause damage to the Hotel, Bus, and Beach Property, and I will pay my rightful share for any damage I may cause or participate in causing.
